Limits of Indemnity:

Sub-section .1. : Public Liability	£5,000,000
Sub-section .2. : Products Liability	£5,000,000

Length Limit:

Maximum Length of vessels which are handled/worked upon by the Insured:

- a) ashore 60 feet length overall.
- b) afloat 60 feet length overall.

Excess: £500.00 (see Exclusion 17)

ENDORSEMENTS:

1. Length Limit.

Warranted that the Length Limit referred to in the Schedule is not exceeded.

2. Trial or Demonstrations of any Customer's Vessel.

Extension 16 is operative.

91 Vessels used in the course of the Insured's business.

Warranted that all Vessels operated by the Insured hold the specific insurance cover applicable for the Vessel's use.

92 Waterskiing(Private and Pleasure use only) Vessel 1 & 2 only.

It is understood and agreed that the indemnities under Sub Sections I & II are extended to include liability to and of persons engaged in waterskiing whilst being towed by the insured craft or preparing to be towed until safely on board the insured craft. Excluding any liability to or incurred by any person whilst engaged in the towing of toys. The limit of indemnity under this extension is restricted to a maximum of £1,500,000.


93 Endorsement: Subcontractors

The Insured shall take all reasonable steps to ensure that in respect of all bona fide subcontractors engaged by or on behalf of the Insured, written evidence shall be obtained prior to work commencing that such subcontractors hold a valid Public Liability policy for an indemnity limit not less than the Limit of Indemnity of this policy which remains in force throughout the period of the subcontract, having regard to the renewal date of said policy.
